Amendments & revision of certain clauses in our constitution as recommended by the Managing committee/ Executive Committee of FSS.

Following are the recommendations:

1. For new membership, the age limit of 65 years will be reduced to 60 years. Necessary changes in the form should be done.

2. Revised Admission fees:

Upto 30 years- Rs. 1000

From 31 to 35 years- Rs. 3000

From 35 to 40 years- Rs. 5000

From 40 to 50 years - Rs. 10,000

From 50 to 55 years - Rs. 15000

From 55 to 60 years - Rs. 25000

3. Notice to all members for Death Contribution shall be sent through Speed post. Along with the physical notice, the email & WhatsApp/SMS shall be sent.

4. The members' contribution for death fund to be sent within 4 months. Thereafter, defaulters will be **AUTO TERMINATED**.

It is not mandatory on the part of the office to send reminders.

5. No provision of retirement after 25 years of continuous membership. (Retirement provision after 25 years of continuous membership is deleted)

6. GOLDEN SHAKE HAND-

But, the Founder, senior members of the age 85 & above will be given option of retirement. If they opt for retirement, they will be paid Rs. 1,00,000 & then they will not be considered as member of the Scheme. If they do not opt for retirement, they shall pay the death fund contribution till they are alive.

This provision in constitution will be called as GOLDEN SHAKE HAND.

7. The jurisdiction of the Scheme shall be Ahmedabad.
